**Councilman Joe Manning** – Stated that the city has received the ACT 13 payment. Advised that the city has applied for the American Rescue Plan Act money and expects to receive over \$1,000,000. He stressed that this money can only be used for specific spending.

Councilman Manning thanked the Dreamers for everything they did last week and in the past for the city. Stated that they put an extraordinary amount of work into the 7<sup>th</sup> Ward Playground.

**Mayor Scott Putnam** – Stated that the District Attorney and Police Department are working on a Grant that would provide Body Cameras for the Police Department.

Discussed the Redevelopment Home Rehab program. They only have two more City Properties on their list and are accepting applications now.
