**Motion** made by Councilman Callan, seconded by Councilman Westcott and carried unanimously to approve the installation of a new waterline at the Washington Park and subsequent payment to Piccolomini Development, not to accede \$5,000.00.

**Motion** made by Councilman Callan, seconded by Councilman DeThomas, and carried unanimously to participate in the glass recycling drop-off program in collaboration with the Washington Rotary and approve related payments from the recycling fund not to exceed \$1,600.00 in 2023.

**Motion** made by Councilman Callan, seconded by Councilman DeThomas, and carried unanimously to accept bids for Police Station roof replacement.

**Motion** made by Councilman Westcott, seconded by Councilman Pintola, and carried unanimously to renew Life/Dental/AD&D coverage with Met Life Insurance Co. and approve payments through 5/31/24. Rate guarantee for 24 months. (6/1/23 through 5/31/25)

**Councilman Joseph DeThomas** – Congratulations to Chief Richer on being appointed as the Emergency Management Contact for the City.

**Councilman Andrew Callan-** The Police Department Building roof is leaking and that is why we need to have it replaced.

**Councilman Joe Pintola** – Street Sweeper was working but now needs repaired. Minor repair. **Councilman Ken Westcott** – Commended Chief Richer on bringing back the tradition of swearing in the firefighters. Stated that he grew up with Bob Griffin and congratulated him on his award and thanked him for his commitment to the City.

Mayor Putnam- Echoed Councilman Westcott's sentiments. Stated that it is great that we are getting qualified applicants for the Fire and Police Civil Service Lists. Announced that the City is going to need to appoint a new Civil Service Board Member to the board. Advised that the Park Cash Bash was a big success and that the Park is ½ way to their goal to pay for this year's Fireworks having raised almost \$14,000.00.
