### **PUBLIC COMMENT:**

John Benko/120 Maple Alley: Complaint about cars without inspection in the alley and speeder in the alley. Would speak with Lt. Devenney and Chief Rush after the meeting. Code Enforcement advised that he cited 1076 Maple Avenue.

**Dave Fraley/309 Taylor Avenue:** Asked again when East Alley would be paved. Councilman Pintola said they would patch but not pave as alleys are not a priority. Mr. Fraley stated that he has been asking for the alley to be paved for 15 years and wanted to know why it isn't a priority. Wanted to know why the stop sign at Arch Street/Taylor Avenue was taken down after the last meeting. Councilman Pintola stated that it was put up illegally and there wasn't a study done to put the stop sign there. Mr. Fraley said that former Councilman Staniszewski had the stop sign put up three years ago. Mayor Putnam said that a Councilman doesn't have that authority to do that on their own and that a study has to be done first and if recommended then City Council has to approve it at a Council Meeting. Mr. Fraley said he will continue to come to speak at Council meetings regarding this issue.

**Fern Sibert/486 Addison Avenue:** Reminded everyone to continue collecting caps for benches and picnic tables through September. Advised that the Rotary will be at the Glass Recycling bins at the Public Works Department on Saturday, August 5, 2023 to collect glass from residents.

**Neil Isiminger/Isiminger Towing:** Presented a check in the amount of \$2,000.00 to the City for the remaining balance owed on the agenda for the Police Department's 6 additional Body Worn Cameras. Mayor Putnam thanked the Isiminger's for their continued support of the police and fire departments.

**Motion** was made by Councilman Westcott, seconded by Councilman DeThomas, and carried unanimously to approve the following refund (a.) in the amount of \$150.00.

**Motion** was made by Councilman Pintola, seconded by Councilman Westcott, and carried unanimously to accept the resignation of Nicholas Bryant (Public Work Department) effective July 21, 2023, amend the Salary Resolution and pay all monies due.

**Motion** was made by Councilman DeThomas, seconded by Councilman Westcott, and carried unanimously to promote police Sergeant John Hritz from the certified civil service list to police Lieutenant effective August 3, 2023, and amend the salary resolution accordingly.

**Motion** was made by Councilman DeThomas, seconded by Councilman Westcott, and carried unanimously to promote police Corporal Kent Mitchell from the certified civil service list to police Sergeant effective August 3, 2023, and amend the salary resolution accordingly.

**Motion** was made by Councilman DeThomas, seconded by Councilman Pintola, and carried unanimously to request the Civil Service Board authorize testing for police promotions for the ranks of lieutenant and corporal.

**Motion** made by Councilman Westcott, seconded by Councilman Pintola, and carried unanimously to authorize Hudson Energy to provide electric at a rate of \$.06630 per kwh for 69 accounts held by the City of Washington from December 2023-December 2024.

**Motion** made by Councilman Westcott, seconded by Councilman Pintola, and carried unanimously to authorize AEP Energy to provide electric at a rate of \$.05644 per kwh for (2) streetlight accounts held by the City of Washington from December 2023-December 2024.

**Motion** made by Councilman Pintola, seconded by Councilman Westcott, and carried unanimously to approve the police department purchase of 6 additional Body Worn Cameras, the associated storage and 1 docking station at a cost of \$24,152.00. This is a 5-year contract with Motorola Solutions; The cameras and docks will be purchased outright from PCCD grant funding along with 2 years of storage at a cost of \$22,352.00. The additional 3 years of storage would be covered by the city at a cost of \$1,800.00.

**Motion** made by Councilman Pintola, seconded by Councilman Callan, and carried unanimously to approve police dept solicitation of bids to install 4 external cameras on the police station. The cost of the installation would be covered by PCCD grant funding with a maximum expenditure of \$8,000.00.

**Motion** made by Councilman Westcott, seconded by Councilman Pintola, and was carried to approve the conditional use request of Buttagi Homes,Inc. for the proposed construction of a four unit multi- family structure located at 570 Jefferson Avenue, Washington, PA contingent upon the grant of a variance for minimum lot width and minimum side yard.

**Motion** made by Councilman Pintola, seconded by Councilman Callan, and carried unanimously to extend a conditional offer of employment to Jeremy Notaro, for a position Laborer/Driver with the Department of Public Works with an official start date to be determined by the City Administration upon successful completion of all required pre-employment screenings and amend the salary resolution.

**Motion** made by Councilman Pintola, seconded by Councilman Callan, and carried unanimously to extend a conditional offer of employment to Alexander Pepper, for a position Laborer/Driver with the Department of Public Works with an official start date to be determined by the City Administration upon successful completion of all required pre-employment screenings and amend the salary resolution.

**Motion** made by Councilman DeThomas, seconded by Councilman Pintola, and carried unanimously to approve selling two pieces of Fire Department training/fitness equipment to the City of Pittsburgh Bureau of Fire for the amount of \$6,800.00.

**Motion** made by Councilman Callan, seconded by Councilman DeThomas, and carried unanimously to approve the plumbing repairs to Tylerdale station with McKean Plumbing, not to exceed \$6,500.00.

**Motion** made by Councilman Pintola, seconded by Councilman Westcott, and carried unanimously to Table the Motion to approve replacing Fire Station Headquarters side door replacement, not to exceed \$4,300.00.

**Motion** made by Councilman Westcott, seconded by Councilman DeThomas, and carried unanimously to appoint Carole DeAngelo to the WBDA at the recommendation and majority vote of the WBDA board, from a list of three candidates, for a 5-year term beginning August 1, 2023 and ending July 31, 2028.

**Motion** made by Councilman Callan, seconded by Councilman DeThomas, and carried unanimously to authorize Harshman CE Group to prepare and submit a DGLVR Grant to Washington County Conservation District for drainage improvements to Twist Way with matching funds to come from money budgeted to repave Twist Way. **Motion** made by Councilman Westcott, seconded by Councilman DeThomas, and carried unanimously to authorize the purchase and approve payment of required fire equipment for the 2023 Pierce Saber Fire Engine:

- a. 96.00/411-000 MARCELLUS SHALE IMPACT FEE FUND Emergency Services-Fire. Cost not to exceed: \$50,000.00
- b. 99.00/411-700 PEMA GRANT FUND Fire Equipment Purchase. Cost not to exceed: \$25,000.00
