ORDINANCE:

FIRST READING of ORDINANCE NO. 1976 NO. 3 of 2024

AN ORDINANCE OF THE COUNCIL OF THE CITY OF WASHINGTON, WASHINGTON COUNTY, COMMONWEALTH OF PENNSYLVANIA, AMENDING THE CODE OF ORDINANCES OF THE CITY OF WASHINGTON, ARTICLE XI – EARNED INCOME TAX, PROVIDING FOR THE REPEAL OF THE SPECIAL TAX, UNDER ACT 205 OF 1984, FOR THE SPECIFIC PURPOSE OF RAISING REVENUE TO DEFRAY COSTS RELATED TO THE PENSION PLANS OF THE CITY OF WASHINGTON.

WHEREAS, the Council of the City of Washington, Washington County, Pennsylvania, is desirous of repealing the special tax, pursuant to Act 205 of 1984, which established a special tax of .02% under the City of Washington Pension Distress status.
